HOW TO NOMINATE

Consider the reputation, experience, acumen, professionalism, commitment to clients and others with whom both individuals or firms work, including involvement in the community, leadership and energy.

Nomination forms must be returned to Birmingham Law Society by **Friday 9th December 2011**

Step 2: Once all entries have been received, nominees will be contacted and asked to supply further detailed information to support their nomination.

Step 3: A panel of judges will short list candidates in each category. Shortlisted nominees in the individual categories (other than Law Firm of the Year categories) will be required to attend an interview with the judging panel.
